1. NOTICE

It's important to Maxpho to help our users retain their privacy when they take advantage of all the Internet has to offer.

Your privacy is important to you and to us. So we'll protect the information you share with us. To protect your privacy, Maxpho follows different principles in accordance with worldwide practices for customer privacy and data protection.

- A. We won't sell or give away your name, mail address, phone number, email address or any other information to anyone.
- B. We'll use state-of-the-art security measures to protect your information from unauthorized users.

We are not responsible for any Personal Information you may directly share with other websites/services inside or outside our website (i.e. Facebook, Paypal, Twitter etc...). Before sharing your information with other companies, read their "Privacy policy" statements.

We do not knowingly contact or collect personal information from children below the age of 18 years. If you believe we have inadvertently collected such information, please contact us so that we can either obtain parental consent or delete the information.

THIS POLICY APPLIES ONLY TO INFORMATION COLLECTED THROUGH OUR WEBSITE AND IS NOT RELATED TO ANY INFORMATION COLLECTED OFFLINE.

2. USER RIGHTS

In accordance with the General Data Protection Regulation (GDPR), consumers have the right to access, correct, transfer and delete their data.

We will ask you when we need information that personally identifies you in behalf of your company (**Personal Information**). Generally, this information is requested when you contact us or sign an online contract:

- CONTACT: the user (in behalf of a company) wants to be contacted by Maxpho (the fields we ask are name, company name, email address and phone number)
- CONTRACT: the user (in behalf of a company) signs an online contract (the fields we ask are first name, last name, company name, company country, email address and phone number)

If, at any time, you do not want us to communicate with you about other offers regarding Maxpho products, programs, events, or services, you can simply email us saying so. You also have the right to object to our processing of your data for the purposes of direct marketing. This can be done by clicking the unsubscribe button in marketing emails.

You have the right to refuse to use our website and to delete your Personal Information, but you need to contact us to do so. We will respond to requests about this within a reasonable timeframe. In case you sign a CONTRACT, we will keep your Personal Information for 10 years from the end of the contract.

3. INFORMATION-GATHERING TOOLS

As you navigate our websites, Maxpho may also collect information through the use of information-gathering tools, such as cookie, web beacons and social media features. 4. SECURITY

Maxpho has taken strong measures to protect the security of your Personal Information and to ensure that your choices for its intended use are honored. We take strong precautions to protect your data from loss, misuse, unauthorized access or disclosure, alteration, or destruction.

We guarantee your e-commerce transactions to be 100% safe and secure. When you use our services on our domains or access your personal account information, you're utilizing secure server software SSL, which encrypts your Personal Information before it's sent over the Internet. SSL is one of the safest encryption technologies available.

Maxpho strictly protects the security of your Personal Information and honors your choices for its intended use. We carefully protect your data from loss, misuse, unauthorized access or disclosure, alteration, or destruction.

Your Personal Information is never shared outside the company without your permission, except under conditions explained above. Inside the company, data is stored in password-controlled servers with limited access. Your information may be stored and processed in the EU and in the US or any other country where Maxpho, its subsidiaries, affiliates or agents are located.

You also have a significant role in protecting your information. No one can see or edit your Personal Information without knowing your user name and password, so do not share these with others.

5. WHAT WE DO WITH THE INFORMATION YOU SHARE

When you join us, you provide us with your contact information, including your name and email address. We use this information to send you marketing materials, to measure your satisfaction with our service and announcements about new and exciting services that we offer.

We occasionally hire other companies to provide limited services on our behalf, including answering customer questions about products or services, call you about exciting services that we offer and processing event registration. We will only provide those companies the information they need to deliver the service, and they are prohibited from using that information for any other purpose.

Maxpho will disclose your Personal Information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Maxpho or the site; (b) protect and defend the rights or property of Maxpho and its family of Websites, and, (c) act in urgent circumstances to protect the personal safety of users of Maxpho, its Websites, or the public.
